SAFEGUARDING AND CHILD PROTECTION INFORMATION

St. Mary's P.S is fully committed to the care and protection of all our children. We aim to protect our pupils by ensuring that <u>all</u> staff, both teaching and non-teaching are trained and have clear guidance on the detection and inter-agency management of child protection issues.

Our Child Protection Policy is based on the following:

- Children should be listened to.
- In any incident, the protection of the child is always paramount.
- That a balance is struck between protecting the child and respecting the rights and needs of parents and families. However, where there is conflict, the child's safety must always come first.

All staff contact with pupils in St. Mary's will follow the guidelines described in the DENI publication.


If a child discloses to a member of staff that he/she is being abused, the member of staff will inform the Designated Teacher, who will inform the Principal. CPSSS will be contacted. The Deputy Social Work Gateway Team, Lingally House Armagh will be contacted.

If a complaint is made against a member of staff, the Principal will investigate and depending on the outcome report to the Chair of the Board of Governors, the Designated Teacher and Deputy Social Work Gateway Team, Lingally House Armagh.

Written records of all incidents relating to child abuse and the actions taken will be kept by the school in a safe and secure place, which is only accessed by the Designated Teacher and the Principal.

In cases of suspected child abuse the school will NOT be involved in investigating the abuse. The action taken is that of informing the Deputy Social Work Gateway Team, Lingally House Armagh, Education Authority Southern Region, CCMS and the Board of Governors.
